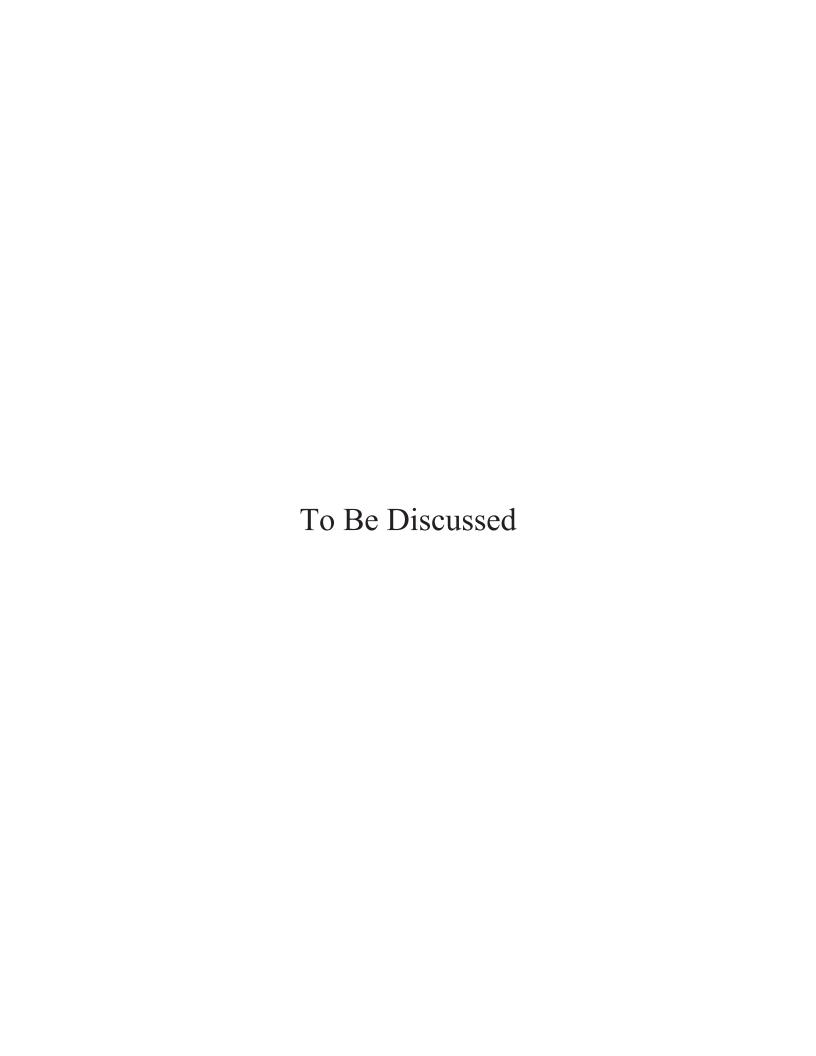

# Tab 6A Approval of the Minutes February 2, 2022 Spring Meeting



#### 2022 Spring Florida Ports Council Board Meeting Wednesday, February 2, 2022, at 1:00 p.m. EST Tallahassee, Florida

#### **MEETING MINUTES**

- 1. Call to Order and Chairman's Welcome: Florida Ports Council Chairman and Port Director of Port Everglades, Jonathan Daniels, called the meeting to order at 1:02 p.m. EST.
- **2. Roll Call:** Chairman Daniels recognized Mike Rubin, President & CEO of the Florida Ports Council, to call roll. The members present were as follows:

3. Port Director Opening Comments: Individual ports provided their overview:

**Port of St. Petersburg** – David Wirth gave the overview for Port of St. Petersburg. Wirth detailed that Port St. Pete has finalized the lease of their largest building on the port and will have new tenants moving in by March 2022. The lease will generate a good revenue stream for the Port of St. Pete.

**Port of Fernandina** – Commissioner Mike Cole gave the overview for Port of Fernandina. Cole detailed that the port has committed to several local agreements with the city that are looking bright and will hopefully change the parameters of issues going forward. The port is also looking to build on the property in which they currently have temporary warehouse tents.

**Port Tampa Bay** – Paul Anderson gave the overview for Port Tampa Bay. Anderson detailed that the port has been seeing strong growth in the second quarter of 2021/2022. Anderson said that the port's containers have increased by about 15%. Also, bringing in 230,000 tons of steel with a huge increase of about 122% over last year, and lumber, even bigger with a 215% increase from last year. This includes 51,000 tons of refrigerated cargo of pineapples, juice, bananas, melons, and other products coming in from Latin America. Port Tampa Bay has also seen a successful restart to cruise. At their recent board meeting, their longtime port tenant Mosaic extended their lease at the port's terminals, which significantly increased the revenue to the port. Anderson mentioned that across all of their lines of business, they continue to see phenomenal growth.

**Port of Palm Beach** – Manuel Almira gave the overview for Port of Palm Beach. Their most recent announcement is that a cruise ship will be given the name Margaritaville at Sea, using Jimmy Buffet's license. This ship will be converted to follow all the décor and colors of Margaritaville brand.

**PortMiami** – Basil Binns gave the overview for PortMiami on behalf of Hydi Webb. Binns congratulated Hydi Webb on her recent transition to interim Port Director. Binns advised that fiscal year 2021 was a great year for PortMiami, specifically December, was their largest in terms of cruise. As of the end of January, the port has had 330 calls since the beginning of fiscal year 2022. PortMiami is finalizing the expansion of a new container yard and waiting for two new cranes to arrive within 60 days. This container yard will add over 250,000 containers with the expansion.

**SeaPort Manatee** – Carlos Buqueras gave the overview for SeaPort Manatee. Buqueras said that they are finalizing the expansion of a new container yard that will add capacity for 250,000 containers. SeaPort Manatee is also waiting for the arrival of two new cranes within the next 60 days.

**Port of Fort Pierce** – Kevin Lindgren gave the overview for Port Fort Pierce on behalf of Stan Payne. Fort Pierce is currently working on their master plan.

**Port Panama City** – Alex King gave the overview for Port Panama City. Port Panama City's containerized cargo is incrementally increasing. FedEx is building their intermodal distribution center on the port. This distribution center will add 200 jobs and is a \$55 million investment with some of the proceeds going to develop an additional 52-acre site next to it.

**Port Canaveral** – Captain John Murray gave the overview for Port Canaveral. Port Canaveral has had a record year for cargo, last year, driven by lumber trade. The port connected with Brightline Construction to bring in 90,000 tons of rail beds from Canada to help them finish a project that was originally coming from Savannah. Port Canaveral detailed that SpaceX plans to launch over 40 launches out of Cape Canaveral this year and it may cause a few conflicts with safety zones.

**Port of Pensacola** – Clark Merritt gave the overview for the Port of Pensacola. Port of Pensacola had revenues increase by 3% in the last year and tonnage up by 13%. The port signed three long-term (10-20 year) leases which include multiple entities like a light industrial manufacturer, hotel, and offshore maintenance.

JAXPORT – Eric Green gave the overview for JAXPORT. Jacksonville closed the year out with its best fiscal year in history. JAXPORT has started their SSA 40-month expansion, which is a \$70 million expansion. At their next board meeting, JAXPORT will change ownership from NLL to series terminals, which is \$80 million over a 20-year period. JAXPORT concluded the commercial terms for a new bill for Southeast Toyota. That's approximately about \$248 million project. Their harbor deepening project has moved up its completion date to March or April of this year. That project was estimated at about a half a billion dollars. It's coming in two and a half years earlier than anticipated and about \$100 million on the budget.

**Port Everglades** – Chairman Jonathan Daniels gave the overview for Port Everglades. Chairman Daniels said that Port Everglades is finishing up the environmental impact statement for their dredging project from February 2020. Everglades is seeing push back from the Army Corps of Engineers due to overall cost associated being roughly \$720 million. Everglades is seeing a significant increase in the size of vessels moving through and number of boxes. Also, a significant increase in their energy sector

**4. Governance and Membership:** Chairman Daniels turned the meeting's focus to governance and membership updates. Chairman Daniels called on Mike Rubin to provide an update. Rubin shared the floor with guest, Sam Sullivan, from Putnam County. Sullivan addressed the Council regarding the potential economic value to Putnam County with the addition of a port in the future. Putnam County will

be doing a feasibility study (post-session) to assess dredging for the navigable channel in the middle of St. Johns River. To wrap up governance, Christy Gandy mentioned the new software system, GrowthZone, that will be utilized by the Florida Ports Council to manage events, contacts, correspondence, etc. The rollout for GrowthZone will be in spring 2022.

#### 5. Administration

- **A. Approval of the Minutes: August 26, 2021, Annual Board Meeting:** Chairman Daniels requested a motion for the approval of the August 26, 2021, Florida Ports Council meeting minutes. A motion was made by Paul Anderson, seconded by David Wirth, and passed unanimously.
- **B.** Budget Report FY 21/22 Financial Statements: Mike Rubin advised that the budget documents and information were in the meeting packet provided ahead of the meeting. There has been no significant change from the annual meeting numbers in August 2021; the budget is tracking along well. Rubin detailed that the Florida Ports Council are being as lean as possible, including no spending of unnecessary money on additional sponsorships, advertisements, and memberships; however, there are a few high-cost items in the future including, the TPM Conference, Congressional Staff Tours, and Mexico-Trade Mission trip.
- C. President's Comments: Rubin thanked Kenyatta Lee for her great leadership and professionalism during the transitional time within FDOT. Rubin also noted that Governor DeSantis signed the resolution for Florida Seaports Day at the Capitol. Rubin thanked the staff at FDOT and his staff for helping bring Florida Seaports Day to life and hopes to continue it annually.

#### D. Program Administration

- **i. FSTED:** Chairman Daniels moved passed the FSTED update, as the meeting was immediately prior to this meeting.
- **ii. FPFC:** Emily Fisher mentioned that there will be a summer Florida Ports Financing Commission Meeting to discuss the 2021 audit and budget moving forward. Fisher will be in touch with the committee members.
- **iii. SEMC:** Chairman Daniels moved passed the SEMC update, as there was an update given during the FSTED Council meeting that was immediately prior to this FPC meeting.
- **iv. Security Committee:** Chairman Daniels skipped passed the Security update, as there has been no recent security meeting.

#### E. Other Issues

- **i. TPM Reception February 28:** Rubin advised that the Florida Ports Council will move forward with hosting a reception at TPM this year. The budget goal for the event is to stay near \$60,000. The participating ports discussed and agreed upon breaking the total \$60,000 cost amongst themselves as follows: \$13,500 for JAXPORT, Port Everglades, PortMiami, and Port Tampa Bay and \$6,000 for SeaPort Manatee (cost subject to be adjusted after getting final cost numbers).
- **ii. FPC Board Virtual Summer Meeting May/June 2022:** The board decided to set up a virtual FPC meeting for the May/June timeframe, unless there is a chance to meet in-person with the new FDOT Secretary at either the Orlando or Tampa Airport for easy commuting access.
- **iii. FPC/FSTED Annual Meeting August 30-September 1 in Key West:** Christy Gandy mentioned that she will send out the hotel room block link when she receives it from Casa Marina Waterfront. Gandy advised to book early due to rooms filling fast and the guaranteed rate.

Chairman Daniels interjected the agenda to discuss AAPA and each Florida seaports' participation. As discussed, the annual AAPA convention is scheduled for October 16-19, 2022, in Orlando and Chairman Daniels opened the floor to discuss the idea of collective participation. Roughly half of the individual

Florida seaports are members of AAPA, with that being said, the board determined that the Florida Ports Council, as a body, may participate, but individual seaports can decide on their own; however, this is to be discussed again at the summer meeting before an official answer. There was also discussion and hesitation from a few ports that AAPA does not support the Jones Act; therefore, they would not be participating in anything related to AAPA.

- 6. Communications/Marketing Update: Edie Ousley with Yellow Finch Strategies provided an update on the Florida Ports Council strategic communications activities and successes performed from September to January. Ousley detailed that October 2021 was a peak month within the last six months. In October, the Florida Ports Council started the Open for Business campaign, which generated 15+ media interviews. Ousley detailed that the ports' exposure and media coverage has increased by 35% in the last six months. Also, the Florida Ports LinkedIn followers have gone up 110%.
- 7. Legislative: Chairman Daniels called upon Mike Rubin to discuss current legislative issues in Florida.

#### A. State

#### i. 2022 Legislative Session

- **a.** Budget/Port Funding/Transportation Package: The Governor's budget includes a significant recommendation on reserves. Initial discussions heard from both the House and Senate appropriators were that he already had asked for significant Emergency Response Funds, that got cut down significantly. So, there is a lot of money that is unallocated at this time and there will be potential funding opportunities later on.
- b. Port-Related: Aerospace Commerce. Transportation Network Companies. State
  Transportation Trust Fund Spending. Port Putnam: Rubin discussed a few bills including
  the aerospace issue and the transportation network companies' amendment that included the
  \$2 per ride limitation. Also discussed was the likely addition of Port Putnam to the FSTED
  council.
- **c.** Partner Issues: No partner issues were discussed.
- **d.** Environmental: No environmental issues were discussed.
- ii. Miscellaneous: No other issues were discussed at the state level.
- B. Federal: Chairman Daniels called upon Mike Rubin to discuss current federal legislative issues.

#### i. Initiatives

- **a.** Congressional LD Tour: The Florida Ports Council did their last two LD port tours in Everglades/Miami and Canaveral/Jacksonville. The Florida Ports Council suggested their next LD port tour be held in Tampa/Manatee during the USF and FDOT Supply Chain Summit. Mike and Christy have been working on the itinerary.
- **b.** FPC 2022 Washington DC Fly-In: The FPC board decided to postpone the 2022 DC fly-in this calendar year, but will continue to keep on the agenda and have discussions for a spring/summer 2023 fly-in.

#### ii. Issues:

- **a. Infrastructure Legislation/Funding:** The board discussed the potential of having a discussion with the MARAD group in the future.
- **b. WRDA/HMTF/Port Investment:** No updates at this time on potential federal WRDA legislation.
- **c. CBP:** After substantial board discussion on the CBP and spacing requirements, Rubin has set up a call with Dr. Foret and his team for February 16<sup>th</sup> at 1:00 p.m. EST. This discussion will be with a smaller group of the ports directly impacted.

- **d. Miscellaneous:** The board discussed the 2022 Port Crane Security Inspection Act that may restrict the use of foreign cranes in the USA. The board discussed the complications this could potentially cause at each port.
- **8. Partner Updates:** The World Trade Center Miami and Enterprise Florida is hosting a trade mission to Mexico in June 2022. The board discussed their individual port participation in this event.
- 9. Other Issues: Chairman Daniels opened the floor to discuss other issues.
  - A. New Business: No new business was discussed.
  - **B.** Port Director Closing Comments: No closing comments were made.
- **10. Adjournment:** Chairman Daniels adjourned the meeting at 4:20 p.m. ET.

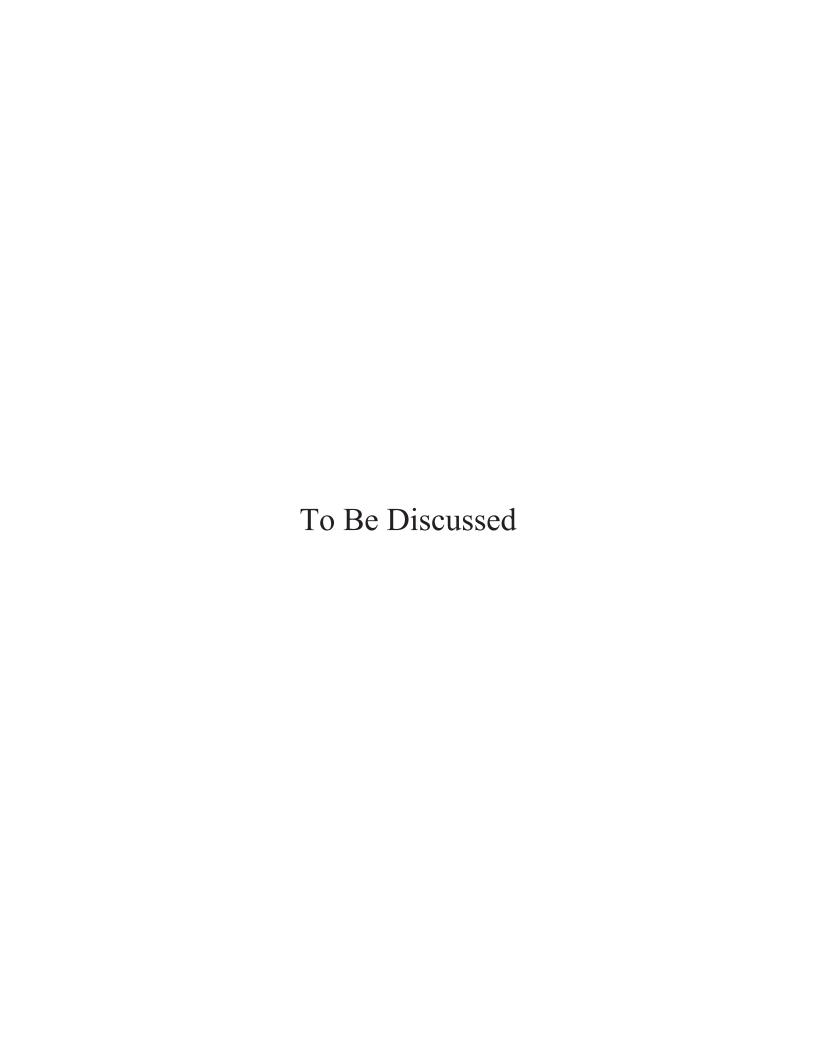

hours of operation at any land port of entry unless CBP can demonstrate that the reduction in hours will not impede local or regional commerce or unduly impede local resident traffic. Further, not later than 90 days after the date of enactment of this act, CBP shall provide a report to this Committee detailing operating hours at all northern border ports of entry, and describing how CBP plans to improve the recruitment and retention of CBP personnel at remote northern border ports of entry to sustain those operating hours. Additionally, to assist with the challenges relating to operating hours, the Committee directs CBP to establish a pilot program for the co-location of CBP and Canada Border Services Agency border agents at remote LPOEs to maintain border security and reduce costs.

Reimbursable Services Programs.—The Committee is dismayed at reports from CBP's port partners on the use of the Reimbursable Services Program. The intent of that program is to enable partnerships with private sector and government entities to provide an opportunity for additional inspection services on a reimbursable basis upon request for stakeholders. The Committee would like to make clear that these reimbursable programs are not to supplant base-line service levels. They are to be used to supplement enhancement requests for service that CBP would be otherwise unable to perform. To better establish expectations for all parties, the Committee reiterates its direction to CBP to provide each port operator with information on baseline service levels and report to the Committee quarterly on CBP's adherence to these baseline service levels. Additionally, the Committee continues a previous request for CBP to include information on requirements for staff, facility, and security upgrades for seaports to include marine and cruise terminals. It should address staffing shortages, upgraded facility and security requirements, and plans for technology recapitalization; the process used to decide how initiatives are funded; a justification for the scope of the requests; and how CBP will negotiate and incorporate the ports' involvement into the development of their capital management plan to allow for early identification and planning for future facility and security needs.

The Committee is also concerned about reports that CBP is imposing costly facility and security requirements on seaports without adequate consultation and justification. The Committee encourages CBP to defer all current and future seaport facility requests until it has provided details on baseline service levels to each port operator and provide the Committee with estimates for future facility and security requirement upgrades and associated federally-mandated technology. The Committee expects CBP to act in partnership with seaports and refrain from imposing requirements on sea-

ports in a unilateral fashion.

Locality Payscale Flexibility.—Recruitment and retention of CBP officers continues to prove challenging, in particular when attempting to fill posts along the northern border in areas with a high cost of living. Many of the officers in these communities are compensated based on the National pay scale as opposed to the localized pay scales that are more reflective of the region's cost of living. In light of these challenges, the Committee directs CBP, in coordination with the Office of Personnel Management, to provide a re-

## SUMMARY SUBCOMMITTEE ON TRANSPORTATION, HOUSING AND URBAN DEVELOPMENT, AND RELATED AGENCIES FISCAL YEAR 2023 APPROPRIATIONS BILL

Chairman's Mark: July 28, 2022

Washington, D.C. – The fiscal year 2023 Transportation, Housing and Urban Development, and Related Agencies (THUD) Senate Appropriations bill provides \$89.048 billion in discretionary budget authority – \$8.01 billion more than the fiscal year 2022 enacted level. The bill makes key investments in transportation and housing programs that will help reduce homelessness, provide housing stability for nearly 5 million low-income households, and improve the safety and efficiency of our transportation systems. The Department of Transportation would receive \$106.6 billion in total budgetary resources, of which \$29 billion is net discretionary budget authority, which is \$2.1 billion above the fiscal year 2022 enacted level. An additional \$36.8 billion in advance appropriations was provided to the Department of Transportation by the Infrastructure Investment and Jobs Act (IIJA) for fiscal year 2023. The Department of Housing and Urban Development (HUD) would receive \$70 billion in total budgetary resources, which is \$4.3 billion above the fiscal year 2022 enacted level, and is offset by \$10.3 billion in receipts from the Federal Housing Administration and Government National Mortgage Association for a net funding level of \$59.6 billion.

**U.S. Senator Brian Schatz (D-Hawaii)**, Chair of the Senate Appropriations Transportation, Housing and Urban Development, and Related Agencies Subcommittee, said:

"Our bill directly addresses America's housing crisis by making the largest investment in affordable housing in a decade – funding the construction of more than 11,000 new rental units and creating a 'Yes In My Backyard' program to incentivize more affordable housing. It also maintains record levels of investment in Native housing, improves our public transit, airports, and roads, and supports domestic violence survivors under the Violence Against Women Act."

#### U.S. Senator Patrick Leahy (D-Vt.), Chair of the Senate Appropriations Committee, said:

"This is a strong bill that makes much needed investments to help our nation's affordable housing crisis. It will support the creation of new affordable housing, shelter hundreds of thousands of homeless Americans, and holds the potential to eliminate veteran homelessness in our country, which is a blight on our promise to serve those who have served our country. It makes critical new investments to improve our nation's infrastructure and further implements the promises made in the bipartisan infrastructure bill enacted into law earlier this year."

#### **Key Points and Highlights:**

**Invests in Infrastructure:** The bill builds on the investments made in transportation infrastructure by the IIJA with increased investments for the following programs:

- \$1.09 billion for the multi-modal RAISE grant program, \$315 million more than fiscal year 2022;
- \$3.06 billion for the Federal Aviation Administration's (FAA) Facilities and Equipment, \$167 million more than fiscal year 2022, to address the FAA's backlog of facilities and towers and to modernize the air traffic control system through NextGen investments;
- \$3.867 billion for the Airport Improvement program (AIP), which includes \$517 million for supplemental AIP grants to improve the safety and capacity of our nation's airports, including projects to reduce the impact of airport noise;
- \$3.2 billion from the general fund for the Federal Highway Administration, \$715 million more than fiscal year 2022, to support additional funding for PROTECT grants for resiliency projects, tribal high priority projects, bridge formula funding, and development of the Appalachian Development Highway System;
- \$2.6 billion for Amtrak, \$269 million more than fiscal year 2022, to support Amtrak operations across 30 train routes to over 500 destinations in 46 States;
- \$200 million for the Federal-State Partnership for State-of-Good-Repair (SOGR) to fund the replacement, rehabilitation, or repair of major infrastructure assets providing intercity passenger rail service;
- \$535 million for the Consolidated Rail Infrastructure and Safety Improvement (CRISI) program, which can be used for a broad range of safety and capital projects such as stations or platforms, rail line relocation or improvement, highway-rail grade crossing improvement projects, and planning and environmental work;
- \$2.51 billion for the Federal Transit Administration's Capital Investment Grants program, \$262 million more than fiscal year 2022, to advance eligible capital transit projects;
- \$527 million from the general fund for Transit Infrastructure Grants (TIG), \$22.8 million more than fiscal year 2022, to advance additional investments into Bus and Buses Facilities, the Low or No Emissions Vehicle Program, Areas of Persistent Poverty, ferry programs, and research to accelerate zero emission technology; and
- \$234 million for the Port Infrastructure Development program, equal to fiscal year 2022, to provide planning and capital assistance to improve the efficient movement of commerce around our nation's congested ports.

the United States. Under the Federal Credit Reform Act of 1990 (Public Law 101–508), appropriations to cover the estimated costs of a project must be obtained prior to the issuance of any approvals for title XI financing.

#### COMMITTEE RECOMMENDATION

The Committee provides an appropriation of \$3,000,000 for administrative expenses of the Maritime Guaranteed Loan Title XI program. This level of funding is equal to the President's budget request and the fiscal year 2022 enacted level.

#### PORT INFRASTRUCTURE DEVELOPMENT PROGRAM

#### PROGRAM DESCRIPTION

The Port Infrastructure Development program is authorized in section 50302 of title 46, United States Code to provide grants for the improvement of port facilities.

#### COMMITTEE RECOMMENDATION

The Committee recommendation includes \$234,310,000 for the Port Infrastructure Development program, which is equal to the enacted level and is \$4,310,000 above the budget request.

Set Asides and Prioritization.—The Committee directs MARAD to set aside 25 percent of the funds for small inland river and coastal ports and terminals, as required by 46 U.S.C. 54301. The recommendation directs MARAD to allow Federal cost shares above 80 percent for projects in rural areas, as permitted by 46 U.S.C. 54301.

#### ADMINISTRATIVE PROVISION—MARITIME ADMINISTRATION

Section 170 authorizes MARAD to furnish utilities and services and to make necessary repairs in connection with any lease, contract, or occupancy involving Government property under control of MARAD and allows payments received to be credited to the Treasury and to remain available until expended.

#### PIPELINE AND HAZARDOUS MATERIALS SAFETY ADMINISTRATION

The Pipeline and Hazardous Materials Safety Administration [PHMSA] was established within the Department of Transportation on November 30, 2004, pursuant to the Norman Y. Mineta Research and Special Programs Improvement Act (Public Law 108–426). PHMSA is responsible for the Department's pipeline safety program as well as oversight of hazardous materials transportation safety operations. The agency is dedicated to safety, including the elimination of transportation-related deaths and injuries associated with hazardous materials and pipeline transportation, and to promoting transportation solutions, which enhance communities and protect the environment.

## SUMMARY ENERGY AND WATER DEVELOPMENT AND RELATED AGENCIES SUBCOMMITTEE FISCAL YEAR 2023 APPROPRIATIONS BILL

Chairman's Mark: July 28, 2022

Washington, D.C. –The Energy and Water Development fiscal year 2022 appropriations bill totals \$57.54 billion in new discretionary budget authority, \$4.6 billion more than fiscal year 2022. The bill provides over \$10.6 billion to improve the nation's water infrastructure, which includes funding for the Army Corps of Engineers' Civil Works program at \$8.7 billion, an increase of \$414 million over fiscal year 2022. Funding for the Corps will be used to build projects that reduce the risk of flood and storm damage, improve the efficiency of our ports, harbors, and inland waterways, and restore aquatic environments. The bill also includes \$1.949 billion for the Bureau of Reclamation, an increase of \$27 million over fiscal year 2022, to assist the Western states in maintaining water supply in rural communities and parts of the country experiencing drought conditions. Additionally, the bill provides over \$49.3 billion for the Department of Energy, an increase of \$4.5 billion over fiscal year 2022.

**U.S. Senator Dianne Feinstein (D-Calif.)**, Chair of the Energy and Water Development Subcommittee, said:

"The Energy & Water funding bill released today by the Appropriations Committee is focused on modernizing critical infrastructure throughout the nation, with a particular focus on climate change programs and California's outdated water system. The bill makes substantial investments in water infrastructure, including \$186 million to fund Western drought programs under the WIIN Act. The bill also shines a light on the need to address the climate crisis, allocating billions of dollars to key programs including a new Domestic Clean Energy Accelerator to support our domestic clean energy manufacturing base. Finally, the bill provides necessary investment in nuclear nonproliferation, including programs that secure radiological materials in the United States and abroad."

U.S. Senator Patrick Leahy (D-Vt.), Chair of the Senate Appropriations Committee, said:

"This bill provides critical resources to support our nation's water infrastructure, our energy sector, and bolsters clean and renewable energy technologies to help us confront the climate

crisis. Importantly, the bill also addresses the consequences of climate change by providing resources to address the historic and debilitating drought in the Western United States."

#### **Key Points & Highlights** –

Corps of Engineers: The bill includes significant funding for the Army Corps' Civil Works program at \$8.7 billion, \$414 million more than fiscal year 2022. For the second year in a row, the bill meets the Harbor Maintenance Trust Fund target providing \$2.318 billion to maintain and modernize our waterways. The Corps maintains our inland waterways and ports, manages a portion of our water supply, provides emission-free electricity from dams, restores aquatic ecosystems, looks after our recreational lands and waters, reduces flooding, and provides emergency response to natural disasters. The annual net economic benefit generated by the Corps' Civil Works mission is estimated to be \$89 billion, which equates to a return of about \$12 for every dollar invested.

**Department of the Interior:** The bill provides \$1.949 billion for the Department of Interior, which is \$27 million more than fiscal year 2022. This amount includes \$21 million for the Central Utah Project and \$1.928 billion for the Bureau of Reclamation.

Funding for the Bureau of Reclamation includes \$186 million to fund Western drought programs under the WIIN Act. The Western United States is currently experiencing unprecedented drought conditions as a result of climate change. These programs fund long-term drought strategies including, water storage, water recycling and reuse, and desalination.

**Department of Energy (DOE):** The bill provides \$49.3 billion for DOE. This amount is \$4.5 billion more than the fiscal year 2022 level. These funds include:

#### Defense Production Act Domestic Clean Energy Accelerator:

The bill provides \$500 million in new funding to accelerate domestic manufacturing of five key clean energy technologies. The funding will help to ensure a resilient and sustainable domestic industrial energy supply chain base to meet the requirements of the clean energy economy as an imperative to strengthening national security, reducing emissions, and creating high quality jobs.

#### Scientific Discovery:

The bill provides \$8.1 billion, \$625 million over fiscal year 2022, for the Office of Science. The Office of Science is the largest federal sponsor of basic research in the physical sciences, and supports 22,000 researchers at 17 national laboratories and more than 300 universities. The bill continues to advance the highest priorities in materials research, high performance computing and biology to maintain U.S. scientific leadership.

#### Tribal Energy:

The bill provides \$110 million for the Indian Energy Policy and Programs, \$52 million over fiscal year 2022 levels, and updates the Tribal Loan Guarantee Program to help Tribal Nations deploy clean energy. The increased funding and new loan authority will also provide new funds to start electrifying the 30,000 tribal homes that do not have access to power.

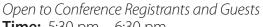

## **CONFERENCE ATTENDANCE**

The 44<sup>th</sup> Annual Joint Meeting will be the most important event in our state's efforts to promote and expand bilateral business ties between Florida and Japan in 2022 and will be officially hosted by Governor Ron DeSantis.

Florida and each SEUS/Japan member state only have the honor and privilege to host every 14 years this important event, which offers a truly unique opportunity to showcase the host state as a great place in which to invest and to do business. The Joint Meeting will allow Florida companies to make personal contact with Japan's top business decision-makers under the most favorable conditions for developing a successful business relationship.

The estimated 400-500 attendees will include CEO's and top executives from leading corporations and organizations from Japan and the seven Southeastern United States. Each of the seven Southeast delegations will be led by their respective Governor. The Japanese delegation will include some 100 top executives from such major global firms such as Bridgestone, Marubeni, Toshiba, Mitsubishi, Toyota, Sumitomo, Japan Airlines and All Nippon Air.

## WHY CO-SPONSORS ARE NEEDED

The Annual Joint Meeting is organized and carried out by Southeast U.S. /Japan Association, a non-profit public-private partner to the State of Florida. Although organized with the cooperation and support of the Governor's Office and various state agencies, including the Florida Department of Economic Opportunity, the



Florida Department of State and Enterprise Florida, it will not be possible to finance the hosting of this important annual joint meeting solely from participation fees from the Japan and seven SEUS member state delegations and any state government contributions. Projected total cost of the event is around \$750,000-\$800,000. The difference between this total amount and the above-mentioned revenues must be obtained from private sector sources through sponsorships and in-kind contributions totaling an estimated \$600K-\$650K.

## **TYPES OF SPONSORSHIP**

## SPONSORSHIP OPPORTUNITIES OVERVIEW

Southeast US/Japan Association is a non-profit, regional organization with extremely limited resources. Although, the joint meeting is organized in close cooperation with and support from various State agencies and Enterprise Florida, it will not be possible to fully finance the entire joint Meeting from delegation participation fees, state contributions, and member-state assessments. Projected total cost for planning, preparing for and carrying out the event and the difference between said funds and the total cost must be made up with contributions from corporate sponsors, economic development agencies and other organizations that have an interest in the success of the Joint Meeting. The cost of the Joint Meeting is estimated at least \$750-\$800K and at least \$600K-\$650K of this needs to be raised through cash and in-kind sponsorships in order to meet the financial commitments for hosting the meeting.

### **TYPES OF SPONSORSHIPS**

A corporation or organization will have the following sponsorship opportunities:

- 1. Hosting a specific event or conference material; or
- 2. Making a non-specific financial contribution to the overall Joint Meeting
- 3. Hosting a Florida hospitality suite

# Florida Trade & Logistics 2030 Study Sets the Course for Florida's Continued Leadership in Trade, Logistics, Exported-Oriented Manufacturing Activities, and Rural Economic Growth

Florida Chamber Foundation Unveils Important Research Essential to Growing Florida's Economy to the Top 10 Globally

As global supply chains change, Florida can be the big winner. A brand-new research report indicates Florida has the available capacity to move more goods, make more goods, and multiply these impacts throughout the economy. Globally competitive trade, logistics, and manufacturing sectors will diversify Florida's economy, bringing new jobs, income and investment into the state. Florida can propel its economy to one of the top 10 worldwide, and today, with the Florida Chamber Foundation's *Florida Trade & Logistics 2030 Study* launch, Florida continues to move the needle toward its continued economic growth.

"Purposely expanding manufacturing, logistics, trade, and rural economic growth aligns with Governor DeSantis' continued leadership in this space and will help grow Florida to the 10<sup>th</sup> largest global economy by 2030." said Florida Chamber of Commerce President & CEO Mark Wilson. "We have a generational opportunity to get this right."

Global supply chains and trade flows are transforming rapidly. The experiences of the past two years—from the global pandemic to extreme weather events to

geopolitical instability in multiple locations—highlighted the vulnerabilities in the global supply chain and the importance of maintaining strong manufacturing and logistics sectors to support Florida consumers and businesses while driving economic growth.



"Many of Florida's peer states are focusing on these opportunities, but the competition in these sectors increasingly is global," said *Florida Trade & Logistics 2030 Study* Project Chair Doug Davidson, Market Executive with Bank of America.

Trade, logistics and manufacturing are essential elements of Florida's economy and offer opportunities for every region of Florida, including rural and inland regions poised for economic revitalization. In 2020, they accounted for more than 1 million jobs statewide—the fourth highest total in the country. As Florida looks to 2030, the state has a wide array of opportunities to build on the strengths of these sectors and address the challenges they face. *Florida Trade & Logistics 2030* presents a series of strategies and recommendations to position these sectors for success and to achieve the ambitious—but attainable—goal of making Florida a top 10 global economy. Some key strategies and recommendations include:

- Reaffirm the statewide priority for trade, logistics and manufacturing
- Establish a statewide, focused manufacturing initiative
- Close essential workforce gaps and strengthen the talent pipeline
- Continue to strengthen trade gateways and corridors
- Establish a comprehensive site development program with emphasis on rural areas
- Continue redesigning Florida's economic development toolkit
- Strategically leverage rural economic development to double the percentage of GDP from rural Florida

"The trade and logistics industry is quickly evolving, and the strength and well-being of Florida's manufacturing economy is inextricably connected to its success," said FloridaMakes CEO Kevin Carr.
