Call to Order, Welcome: The Seaport Environmental Management Committee (SEMC) meeting was called to order at approximately 9:10 a.m. EST by Chairman Joshua Revord, Port Director of the Port of Fort Pierce. Chairman Revord welcomed attendees and noted that today's meeting would include updates from key agencies, environmental discussions, and discussions on regulatory changes impacting port operations.
- 2. Roll Call: Chairman Revord recognized Emily Fisher, Vice President of Programs & Government Relations at the Florida Ports Council, to call the roll. A quorum was present. Members and other guests present were as follows:

**3. Approval of the August 28, 2024, SEMC Meeting Minutes:** Chairman Revord asked for any comments or revisions to the August 28, 2024, meeting minutes. After no discussion, Sam Sullivan



(Port Putnam) made a motion to approve the minutes as stands; then seconded by Becky Hope (PortMiami) and passed unanimously.

4. Florida Ports Council Update: Chairman Revord recognized Mike Rubin, President and CEO of the Florida Ports Council, to give a brief update on legislative and regulatory challenges facing Florida seaports. Rubin stated that the legislative session is in its fourth week; key budget discussions are underway, notably regarding potential amendments affecting transportation infrastructure and the Strategic Intermodal System. Rubin acknowledged concern expressed by stakeholders (including transportation builders) about potential impacts on ongoing projects. Additional, ongoing monitoring of transportation legislation; further updates anticipated as the legislative session progresses.

#### 5. Agency Updates:

- **a.** Florida Department of Environmental Protection (FDEP): Chairman Revord recognized both Gregory Garis, Program Administrator in the Office of Resilience & Coastal Protection, and Lainie Edwards, Deputy Director in the Office of Resilience & Coastal Protection, to give the update for FDEP. They addressed the following updates:
  - New leadership and staffing updates:
    - Alexis Lambert appointed as new Secretary (since December).
    - Mara Gambineri named Chief of Staff.
    - John Truett returns as Deputy Secretary for Regulatory.
    - Lawrence Glenn was appointed as head of the Division of Environmental Assessment and Restoration.
  - Resilient Florida Program: Recently announced resilience grants for 2025; detailed information available online.
  - Rulemaking: Updated Resilience Rule (62-S8) for consistency with statutory requirements; workshops completed.
  - Coastal Mapping Initiative:
    - Statewide project underway for comprehensive coastal data using LiDAR and sonar
    - Data collection ongoing; deliverables anticipated by August 2026, with public portal launch in 2027.
  - Coral Conservation Aquatic Preserve: No immediate impact on permitting or construction methods; awaiting potential future rulemaking on anti-degradation standards.
  - Beach and Dune Recovery:
    - Completed assessments after Hurricanes Debbie, Helene, Milton.
    - Significant funding (\$246 million) is allocated due to increasing dredge mobilization costs.
    - Highlighted ongoing challenges with dredge availability, noting recent lack of competitive bids.

## FSTED

### Florida Seaport Transportation and Economic Development Council

- Consistency in Mitigation Policy:
  - Active discussions aimed at standardizing district office approaches to surface water filling mitigation.
  - Encouraged early and frequent pre-application meetings for clarity.
- b. Florida Department of Transportation (FDOT): Chairman Revord recognized Lauren Rand, Seaport Manager, to give the update for FDOT. Rand discussed the efforts to integrate seaport projects into the ETDM system continue, despite initial complexity. Rand said volunteers from Seaport Manatee, Tampa Bay, Everglades, and Miami submitted projects; encountered complications with MARAD review processes and that additional seaport volunteers and projects required to further test and refine ETDM integration process. Rand emphasized ongoing importance of streamlined project review processes, particularly NEPA, to facilitate permitting.
- **c. FloridaCommerce:** Chairman Revord recognized Jason Mahon, Deputy Director, to give the update for FloridaCommerce. Mahon emphasized FloridaCommerce's role in supporting ports through economic and business development. Mahon offered assistance in addressing barriers or concerns related to commerce and business operations and detailed efforts ongoing to streamline reviews of funding sources like Intermodal Logistics Center funding and Fed funding.
- d. U.S. Army Corps of Engineers Civil Works and Regulatory Divisions: Chairman Revord recognized Angie Dunn, Chief, Planning & Policy Division at USACE Jacksonville, to give an update for the U.S. Army Corps. Dunn gave updates on major projects: Port Everglades: Supplemental Environmental Impact Statement and Endangered Species Act coordination continue; updating total project cost. Miami Harbor Deepening: Extended timeline requested for completion; vertical team review ongoing. Tampa Harbor: Authorized for deepening; entering design phase. Dunn also detailed the mitigation efforts detailed, notably coral impacts and the newly listed Queen Conch; coordination ongoing with National Marine Fisheries Service (NMFS).
- **e.** Florida Inland Navigation District (FIND): Chairman Revord recognized Janet Zimmerman, Executive Director, to give the update for FIND. Zimmerman mentioned the current dredging and sediment management projects highlighted, including Peanut Island habitat creation. Zimmerman noted challenges with NEPA compliance and delays from required consultations, notably with newly listed Queen Conch, impacting timelines significantly.
- f. Florida Fish & Wildlife Conservation Commission (FWC): Chairman Revord recognized Josh Cucinella, Land Use Planning Program Administrator, to give the update for FWC. Cucinella gave an update on wildlife-related regulatory actions (Rice's Whale, Right Whale, Sea Turtles, Queen Conch, Manatees). The Rice's Whale and Right Whale seasonal speed rule proposals were withdrawn by federal regulators. Cucinella highlighted emerging lighting issues related to turtle nesting at certain ports, emphasizing importance of mitigation and communication with FWC for ongoing issues. Additionally, ongoing coordination to streamline wildlife-related permitting issues, citing the recent Port Canaveral expansion coordination as an example.



#### 6. Partner Updates:

- **a.** AAPA: No update, as no attendees were present.
- b. Florida Ocean Alliance: Chairman Revord recognized Lenore Alpert, Executive Director of the Florida Ocean Alliance, to give an update. Alpert mentioned their upcoming Florida Oceans Day on April 1 which features exhibits and public engagement at Capitol Plaza, Tallahassee; additionally with a legislative reception planned, encouraging broad attendance from stakeholders.
- c. Florida Recycling Partnership Foundation: Chairman Revord recognized Keyna Cory, Executive Director of the Florida Recycling Partnership Foundation, to give an update. Cory highlighted success of recent business recycling webinar and future recycling educational initiatives. Cory addressed ongoing legislative focus on battery recycling due to fire hazards and environmental concerns. Cory mentioned their upcoming webinar planned addressing public recycling away from home, targeting business improvement in recycling practices.
- 7. Guest Speaker Dr. Bill Precht "Ten Years Later: The Port Miami Deep Dredge Project Reveals Valuable Lessons Learned to Help Guide Future Projects" Chairman Revord recognized Dr. Bill Precht, Director of Coastal and Marine Sciences at Bio-Tech Consulting. Dr. Precht provided detailed insights from extensive monitoring and analysis following the Port Miami dredging. He clarified misconceptions about sediment impacts, turbidity sources (Miami River discharge vs. dredging activities), and the stony coral tissue loss disease impacts on regional coral populations. He also highlighted data-driven analysis, emphasizing wave actions as primary drivers of sediment deposition rather than dredging operations alone. Additionally, he noted regulatory challenges, advocating for clear scientific basis in future project assessments to avoid misconceptions influencing future policy and regulatory decisions.
- **8. Open Discussion:** Chairman Revord recognized Jeff Littlejohn, Senior Policy Advisory with Adams and Reese and environmental consultant to the Florida Ports Council, to lead an open discussion on the following:
  - **a.** Rice's Whale and Right Whale Speed Rule Update: Littlejohn confirmed withdrawal of federal seasonal speed rule proposals, relieving immediate regulatory concerns for ports.
  - **b. FDEP Stormwater Rule:** Littlejohn detailed that new stormwater regulations become fully effective December 2025; encouraged early application submissions to avoid delays and increased regulatory burdens.
  - c. Federal Updates (WOTUS, NEPA, etc.): Littlejohn discussed fluctuating federal policy landscape, noting significant changes in the definition of Waters of the United States (WOTUS). He detailed potential implications for Florida ports regarding jurisdictional waters; emphasized monitoring ongoing policy developments closely. He updated members on current and forthcoming federal actions regarding NEPA implementation and regulatory changes, highlighting the need for continued engagement.
  - **d.** Other Issues: No other issues were discussed.
- **9. Adjourn:** Chairman Revord opened the floor for discussion; hearing none, the meeting was adjourned at 12:00 p.m.
