Agenda Item 3, Approval of the Minutes of August 30, 2017, FSTED Council meeting, was taken up. A motion was made by Mr. Kancharla, seconded by Mr. Murray, and passed approving the minutes.

Chairman Stubbs also informed the members that a new chairman of the FSTED Seaport Environment was required,

and that he had appointed Erik Neugaard, Port Everglades Environmental Manager, as the chairman of that Committee.

Agenda Item 4, Report on Security Committee, was taken up. Mr. Rubin provided the members with a report on the Committee. Mr. Rubin provided the members with information on the Port Security Conference held in Orlando in November. The Conference was very successful, with several presentations on cybersecurity and various types of security technologies and applications. The Committee was still looking at holding another conference next November, but wanted to discuss the issue with all the port directors prior to scheduling any addition conferences. The conferences tend to be expensive to conduct, and at this time we may need additional sponsors or more contributions from our seaports to hold another conference.

Mr. Rubin reminded the members that the Florida Legislature appropriated \$500,000 to the FSTED Program specifically for port security grants. The FSTED Security Committee met formally on Thursday, November 30<sup>th</sup> to review applications from the seaports for security grants. Mr. Rubin directed the members to the report in their materials containing the recommendations of the Committee. Three applications were submitted – cloud based physical security system from Port Canaveral (\$200,000); North Gate Expansion Project from Port Manatee (\$315,650); and a statewide situation awareness and collaboration platform for seaports and agency partners (\$500,000). The recommendation from the Committee was to fully fund the statewide situation awareness and collaboration platform at \$500,000. If that project was unable to be completed, the Committee recommended providing \$300,000 for the Port Manatee project and \$200,000 for the Port Canaveral project. The members discussed the recommendation and proposed projects. Chairman Stubbs asked whether procurement and other issues had been worked out, and Mr. Rubin stated that FSTED Council staff was working with FDOT to ensure compliance with legislative mandates. Mr. Brown from Ares Corporation provided the members with additional information on the proposed statewide project. Mr. Cernak made a motion, seconded by Mr. Kancharla to approve the recommendations of the Security Committee concerning allocation of funds to the statewide project. The motion was approved unanimously.

Agenda Item 5, Presentation by CPCS Consultant on Distribution Center and Related Logistics Investment Study, was taken up. Ms. Keller reminded the members about the study and the firm the FSTED Council engaged in June of last year. Mr. Roy and Ms. Drake presented a PowerPoint overview presentation on the status and findings of the study. Mr. Roy stated they were still finalizing the report, and developing a marketing plan/brochure to go along with the final report. Final material should be delivered to FSTED Council staff within a couple of months. Chairman Stubbs stated that he looked forward to digging into the findings with our partners at FDOT and DEO.

Agenda Item 6, Legislative Report, was taken up. Mr. Rubin provided the members with an update on committee hearings in the Florida Legislature. The House and Senate have wrapped up their initial discussions on their respective budgets, and those budgets should be available for conference negotiations soon. The good news for seaport projects in the transportation budget is that they are totally funded in both the House and Senate budgets. There were several member transportation projects in both budgets, and everyone expects additional projects to be added to the final bill by House and Senate leadership. The 2018 Regular Session is almost halfway completed, and many of the substantive committees have completed their business. The expectation is that the House and Senate will not pass many substantive issues, and should complete their only constitutionally required duty – passing a budget.

Agenda Item 7, Agency Reports, was taken up. Mr. Britton provided the report for DEO, and provided the members with the latest economic impact numbers in the state. Mr. Britton informed the members that DEO had received 227 applications for Job Growth Grant Funds, including nine port projects. Mr. Britton stated that DEO was still reviewing all of the projects, and award announcement should begin very soon.

Mr. Emerson provided the report for FDOT, and provided the members with the current status of seaport projects in the FY 2017/18 budget. Mr. Emerson noted that this year's hurricane season really highlighted the importance of Florida's seaports to the state. Mr. Emerson provided the members with FDOT's report and one-page hand out on the impact of

the widening of the Panama Canal on Florida's seaports. Mr. Emerson informed the members about an upcoming webinar meeting of state Freight Advisory Committee on February 6<sup>th</sup>, and noted that Ms. Keller was a member of that Committee on behalf of the FSTED Council. Ms. Keller noted that Ms. Miller also serves as Chair of the Committee. Mr. Emerson stated that he would be retiring in June of this year from FDOT, and thanked everyone for their support and professionalism over the past years. Chairman Stubbs expressed his appreciation on behalf of all of Florida's seaports for his service.

Agenda Item 8, Strategic Intermodal Systems (SIS) Plan New Designation Structure, was taken up. Mr. Chris Edmonston provided the report. Mr. Edmonston informed the members that he was the statewide planning manager for the SIS, and provided a PowerPoint report to the members on the changes and current status of the SIS Program. Mr. Edmonston informed the members that FDOT was proposing additional changes to the SIS Program, and members could still provide comments to the proposed updates. Mr. Edmonston noted that the FDOT has reached out to the FSTED Council and other seaports for their input. Mr. Edmonston provided the members with his contact information.

Agenda Item 9, Project Updates and Review of Seaport Funding Spend Downs, was taken up. Chairman Stubbs noted that he had reviewed the reports in the materials, and noted no concerns. Chairman Stubbs stressed that members should continue to review their project spend downs before the submission of any new projects. Mr. Emerson stated that spend down by seaports has continued to improve since 2015, and congratulated everybody on their work.

Chairman Stubbs stated that this was the first FSTED Council meeting since the adopting of the policy to allow for the movement of small balances remaining on projects on to other approved projects. Chairman Stubbs noted that Fernandina had recently used the policy, and had provided a report to FSTED Council staff.

Agenda Item 10, Agency Reports on Consistency Review of FY 18/19 FSTED Program Project Application, was taken up. Port Manatee has submitted a request to reallocate some funds. In order to move the funds to their preferred project, Port Manatee has submitted a project modification – Cold Storage Warehouse – for review by FSTED Council Agencies. FDOT and DEO have found the project consistent with the requirements of Chapter 311, F.S. Mr. Sanford provided the members with an explanation of the project and the request for reallocation of existing funds. Mr. Kancharla made a motion, seconded by Mr. Cernak, to approve the consistency findings of FDOT and DEO. The motion was unanimously approved. Mr. Kancharla then made a motion, seconded by Mr. Cernak, to approve the reallocation of \$5,000,000 to the project. The motion was unanimously approved.

The meeting was adjourned at 2:40 p.m.

Agenda Item 3, Update on Seaport Mission Plan, was given by Toy Keller. The final draft of the Seaport Mission Plan has been reviewed and will be sent to the designer on Friday. At the

same time, it will be sent to the ports for a quick look. Ms. Keller said the document was scheduled to be finalized, printed and released by the end of April or beginning of May. She indicated that the news in the plan was good: trade values, cargo tonnages, TEUs and cruise passengers numbers were all up in 2017. Chairman Stubbs asked that ports respond to the FPC quickly on the Seaport Mission Plan so it can be completed in a timely manner.

Agenda Item 4, Update on Distribution Center and Related Logistics Investment Study, was given by Ms. Keller. She reported that final edits to the study went to the consultants, CPCS, on April 10, and she will be discussing some other minor revisions to the focus of the study with them later this week. She said staff will be having discussions internally over the next couple of weeks about a strategy for release of the study relative to timing, target audiences, and marketing materials.

Agenda Item 5, Approval of Reallocation of FY 16/17 and FY 17/18 FSTED Program Funds, was taken up. Chairman Stubbs noted there were two ports with funding requests — Canaveral and St. Pete. Pat Poston explained the reason for Canaveral's request to move funds from one approved FSTED project to another approved FSTED project. Canaveral's request and explanation were also provided in a letter in the meeting materials. Ram Kancharla made a motion which Steve Cernak seconded to approve the request. It was approved by a voice vote. David Wirth explained that there had been a delay at the federal level in St. Pete's Marine Science/Research Facility, and requested that funds be moved into next fiscal year. St Pete's request and explanation were also provided in a letter in the meeting materials. Steve Cernak made a motion which Ram Kancharla seconded to approve the request. It was approved by a voice vote. Chairman Stubbs pointed out that a chart describing the funding moves was also included in the meeting materials.

**Agenda Item 6, Other Issues**, was taken up. Mike Rubin provided the members with an update on the D.C. Fly-In scheduled for April 17<sup>th</sup> and 18<sup>th</sup>. Congressional members have requested information from the port on Customs and Border Protection (CBP) and Army Corps funding issues. Chairman Stubbs asked for the members to contact Mike Rubin with any information or issues they had with CBP staffing and Army Corps funding.

Dear Mr. Stubbs:

Canaveral Port Authority (CPA) requests \$149,122.50 in grant funding to replace our aging and obsolete License Plate Reader (LPR) system. (Total Cost of Project \$198,830.00; Port 25% share \$49,707.50)

The Port's current LPR system of 15 cameras were installed in 2012. Only 1 of the 15 cameras is operational and the technology is obsolete. The LPR system is an integral part of the Port's Facility Security Plan.

Our LPR system monitors all access routes into the Port and cross references the plates against law enforcement databases. The requested system collects over 40 million LPR records per month from law enforcement and private sources across the nation. The LPR system allows for customization for security, access control, and parking. This system is set to monitor for outstanding warrants, sexual predators, amber alerts, silver alerts, and active federal, state, and local lookouts for vehicles including terrorist suspects. The system automatically alerts with a vehicle picture and location to the Brevard County Sheriff Office's (BCSO) Port Operations Center for immediate Deputy response. BCSO can also input license plates for individuals trespassed from the Port and security risks identified by Space X and Blue Origin for their high-profile owners. The LPR system gives us an early warning of threats entering the Port and the ability to intercept them before they can harm the 4.5 million cruise passengers who past the Port every year.

An itemized listing of costs for the purchase, installation, and warranty of the proposed LPR system is attached. Identification of the proposed system was a joint effort between CPA and the BCSO.

CPA will fund 25% of the project's total cost from Port revenue.

**RE: FSTED Seaport Security Grant Funding Request** 

Dear Mr. Stubbs:

I am pleased to submit this request for seaport security grant funding for consideration by the FSTED Seaport Security Advisory Committee. Port Everglades requests \$40,000 to fund an upgrade to the Port's existing Maritime Domain Awareness (MDA) radar system.

In 2013, the Port applied for FEMA Port Security Grant Program Funding and was successful in receiving funding to install two surface search radars. The radar installations were intended to increase overall MDA for security staff as well as port operations staff in low light or poor weather conditions, while providing real time data that supplemented information provided by the Automatic Identification System (AIS). The live data from the radar is integrated into the Port's Command Bridge system and provides both the Harbormaster Tower and Security Operations Center (SOC) with information that is useful for collision avoidance, vessel arrival times, and potential threat identification. The two radar sites are aligned in such a manner that the two "pictures" oversee the Entrance Channel, Turning Basin, U.S. Coast Guard designated Security Zone, and offshore approximately ten miles.

In 2017, Hurricane Irma damaged one of the radar installations. While repairing the system, it was discovered that the software developer was purchased by a new company and had not upgraded their technology, nor could they promise a successful repair of the unit. In working with the system integrator, Port Everglades staff was able to identify the issue as a faulty component in a circuit board and effect the repairs on site, which expedited returning the unit to service.

While exploring options to repair or replace the existing equipment, the manufacturer of the radar unit advised Port staff that they had partnered with a software developer and engineered new hardware and software that could convert the system from analog to digital and further improve the overall performance, effectively doubling the effective range of the radar, based on the current system installation elevation.

Port Everglades is seeking funding in the amount \$40,000, with a minimum match provided by the Port of \$13,341.17 based on the attached quote that itemizes the equipment, installation, software, and travel costs. Funds in this amount have been allocated from the Port's Capital Fund and meets the 25% match requirement. Any additional unforeseen costs will be absorbed by the Port.

The United States Coast Guard (USCG) has identified a small boat incursion as one of the highest vulnerabilities to a maritime facility. Early detection or identification of a potential threat by our staff in the SOC or Harbormaster Tower would allow immediate notification via VHF radio to the various law enforcement entities that both patrol and reside in the area (Port Everglades Harbor Patrol, Broward Sheriff's Marine Units, Florida Fish and Wildlife Conservation, Commission Marine Unit, and USCG) as well as the commercial and pleasure boat traffic transiting the area that a potential threat exists.

Grant funded resources for this project will drastically improve the common operating picture available to Port staff. Up-to-the-minute data feeds from an extended detection range, as well as better radar coverage within the Port's security zones, will provide faster identification of possible maritime traffic issues or potential threats while allowing for quicker resource deployment, response times, and that extra few minutes to make the right decision. These improvements will directly enhance the MDA elements in the Port's Security Plan, increase efficiency in screening vessels transporting cargo and passengers, and allow for more rapid communication of security threats to law enforcement agencies.

JAXPORT Public Safety respectfully requests consideration for grant funding provided under the Florida Seaport Transportation and Economic Development (FSTED) Grants Program.

#### **JAXPORT Public Safety Operations**

JAXPORT supports thirty-three (33) maritime facilities including Carnival Cruise Lines. JAXPORT provides port physical security infrastructure, access control (TWIC) implementation and uniformed law enforcement/security personnel on a 24/7 basis. JAXPORT manages all critical incidents including manmade and natural e.g., bomb threats, fire, explosions, intruders, active shooter, and hurricane response and recovery. JAXPORT Public Safety functions as the Incident Commander during critical incident response in accordance with the National Incident Management System (NIMS). JAXPORT Public Safety handles the arrival and departure of all cargo and cruise vessels, to include restricted area monitoring for TWIC compliance, as well as vessel facility interface. JAXPORT provides waterside security (small craft patrol) for four terminals spanning 14 miles along the St Johns Navigational waterway. JAXPORT Public Safety Marine Unit operates under the AMSP, Maritime Joint Terrorism Task Force, outfitted with Blue Force Tracker for monitoring via USCG Command Center. JAXPORT also handles U.S. and foreign national crewmember departure and or entry into restricted access areas as coordinated via tenants, vessels, and/or ships' agents. JAXPORT is responsible for assisting Customs and Border protection Officers with Radiation Portal Monitoring as defined by MOU, and employs personnel worn RAD type pagers.

#### **Project #1** (Installation of Fixed Access Control Readers at JAXPORT Cruise Terminal)

The JAXPORT Cruise Terminal is currently undergoing a major renovation to support our long-term contract with Carnival Cruise Line Services in Jacksonville, Florida. JAXPORT owns and operates a Public Safety Operations Center to include providing 24/7 personnel assigned to monitor various terminal sensors (e.g. CCTV, Intruder Detection System, Fire Alarms, Weather Service) and conducts radio communications internally/externally with local, state, and federal agencies. JAXPORT serves as the first line of defense, in the port's layered defense program and provides direct and indirect security, law enforcement and emergency management in support of Carnival Cruise Lines operations. Carnival Cruise Lines currently handles over 200,000 passengers annually at JAXPORT with increased passenger volume anticipated.

JAXPORT is seeking to incorporate fixed access control readers inside the cruise terminal to provide validated access control of cruise terminal employees (ILA baggage handlers, contract security personnel and Inter-Cruise Services). The aforementioned readers will have biometric capabilities (expected to be required by federal regulation). The readers will increase overall implementation of JAXPORT's plan and security measures at the cruise terminal. The addition of the fixed access readers will also expedite the ingress/egress of approved personnel.

JAXPORT assumes the role of managing a 24/7 Port-wide Inter-operable Communications Program (PICP) system and supporting maritime interests for all Northeast Florida regulated and unregulated facilities. JAXPORT currently has a wireless link to the City of Jacksonville (P25 800 MHz) First Coast Radio System, which allows JAXPORT to have interoperable communication with local, state and federal partners. JAXPORT is seeking to connect to the City of Jacksonville's fiber network to insure continuous and uninterrupted operations at JAXPORT's 24/7 dispatch center.

This will reduce the JAXPORT communication vulnerability to hazardous weather conditions common in Florida (e.g. lightning strikes, driving rains and gale force winds). The City of Key West is pleased to submit the following project for Seaport Security Grants funding for consideration by the FSTED Council Seaport Security Committee:

- Name of Project: Security Cameras: Mallory Square and Outer Mole Pier
- Description of the proposed security enhancements: This project will install a total of five (5) high resolution security cameras at the security checkpoints and secure areas of both Mallory Square and Outer Mole Pier. The project will satisfy both 33CFR105.275 and the City's approved Facility Security Plan which requires the continuous monitoring of the facilities. The system will include recording and play back capabilities of up to 45-days.
- The enhancements will allow the Key West Police Department to monitor the secure areas of both facilities during times when cruise ships are docked and when dock is vacant. The cameras will also allow the police to monitor cruise ship passenger transportation vehicle operations, passenger screening activities, identification of unauthorized persons in the secure areas, and any other potential security risks both landside and waterside.



**Applicant:** Manatee County Port Authority – Port Manatee

**Funding Requested:** \$312,525

**Project:** Port Manatee – North Gate Expansion Project

**Project Description:** The project requested in this investment is a construction project which will provide site work and base infrastructure to modernize and expand the port's north access gates. Two additional traffic lanes will be added to the existing gate complex to support enhanced screening and modernized equipment to support the cargo activities of the port and its operators.

The U. S. Coast Guard Captain of the Port has identified attacks on ammonium nitrate fertilizer operations as a mitigation priority in the Area Maritime Security Plan (AMSP). The frequency and quantity of these operations has dynamically increased making the movement of this cargo a high priority. Currently this cargo is moved off-port to nearby facilities for storage. The current gate configuration is not well-suited for the processing of this traffic along with the cargo of other operators. Modernization of this gate will provide the capability of processing both higher cargo volumes, and to establish cargo lanes dedicated to specialized operations improving both efficiency and overall security.

The current North Gate complex consists of four inbound access lanes and two outbound lanes. A FIPS 201 compliant card reader system is installed to allow the utilization of the TWIC as the port's primary access control system. The readers are connected to an integrated command and control system allowing for the verification of personal card status, level of access, and escort status of all personnel entering the port. Likewise, cargo status and release verification are included in the gates integration to ensure proper cargo control. Implementation of this project will modernize these capabilities allowing the port to better support the increased volume and diversification of tenant cargo operations.

Over the past three years the port's role as a fuel distribution point coupled with significant increases in container and bulk cargo volumes has impacted the ability of the port's ability to process the increase in outbound cargo volumes. In 2017, the port requested and received a grant through the Federal Port Security Grant Program. The funding requested in this application will be used to meet the cost match requirement required for implementation of the project.

Explanation of how the security enhancements will improve the port's ability to screen cargo and/or passengers, and notify local, state, and federal law enforcement of potential security risks: Port Manatee is a landlord / tenant port, which incorporates multiple terminals into a common fenced perimeter. In 2016 Port Manatee implemented a unified MTSA Facility Security Plan (FSP) replacing the FSPs of several tenant facilities. Access Control, including TWIC enforcement and monitoring are provided by the Port Manatee Security Department as part of a coordinated security approach maximizing the effectiveness of security throughout the port.

## FSTED Program Seaport Security Grants Fiscal Year 2018/19 Grant Application

The configuration of the port's security infrastructure was predicated by the Seaport Security Standards previously outlined in Florida Statute 311.12. The statute assigned security responsibility for access control and cargo screening to the port. Port Manatee still operates using this process. Cargo verification and screening are done at the port's access gate. The requested funding will allow screening.

An itemized listing of costs associated with the proposed security enhancements: The funding requested will be used to meet the cost share requirement of two investment justifications (IJ) which were previously approved through the Federal Port Security Grant Program. The first IJ is for the construction of the additional lanes and associated infrastructure. The second IJ provides the equipment necessary to integrate the new lanes into the port's access control system and associated security systems. Implementation of both IJs is necessary to complete the overall project.

We are respectfully requesting funding from the FY2018 Port Security Grant Program (PSGP) for forty-three Night Vision Cameras AXIS Q6125-LE-PTZ.

The AXIS Q6125-LE cameras are outdoor ready PTZ dome with HDTV 1080p, 30X optical zoom, and fast and precise pan/tilt for wide area coverage and detailed surveillance at great distances. The high light sensitivity and day/night functionality ensure high image quality even in low-light conditions. With guard tour, it is possible to direct the camera automatically to 256 preset positions. Temperature control ensures safe startup in extreme cold. Cameras offers shock detention, automatic defog and built in video analytics, such as highlight compensation, object removed, enter/exit detention, auto tracking and active gatekeeper.

The purpose of night vision cameras is to be able to see waterside at night and for the use in navigation, surveillance to monitor the surroundings. A night vision camera can reveal whether an area has been disturbed. When dealing with safety and security, best practices suggest that the element of surprise is key. Night vison cameras are essential in maintaining this because they allow for clear and immediate detection of any illegal activity without alerting the suspects that they are being surveilled. These cameras will also assist in later prosecution of any criminal activity being that they maintain a digital recording of the events as they transpired.

Recently the License Plate Readers (LPR) cameras were repaired to include the updating of the software used in screening all cars that enter the Port. The addition of the 43 AXIS Q6125-LE cameras would assist in the overall Port's plan to increase safety and security. Additionally, being able to view night time activity will increase the Port's ability to assist other local, state and federal law enforcement entities. In the event that a nefarious type of attack were initiated on the Port at night time, being able to relay detailed information to those other agencies is paramount to apprehension of those responsible. Should other law enforcement entities issue a wanted message for vehicles or persons, having these cameras would increase the probability of apprehension because it allows for a clear view of the port throughout the night and not just during the day when sunlight is necessary. The screening of cargo and passengers would also be greatly improved by this equipment addition.

The Port has secured matching funds of at least 25% of the total cost of the project.

Under the auspices of the FSTED Program Seaport Security Grants - Fiscal Year 2018/19, the Port of Palm Beach respectfully requests \$51,263 for a perimeter security detection system for the Port's Restricted Areas.

This perimeter security system will allow for real time detection and notification of unauthorized persons who have scaled the fences and entered the Port's Restricted Area. The system will be programed to notify the Port's Security Operations Center and the Riviera Beach Police Department.

The following equipment will be purchased and installed in support of this project:

5 – 16 Zone Expanders for Interlogix Panel @ \$90.00 = \$4,500

20 - Optex SL-350QFRi @ \$1200 each = \$24,000

10 – EN5040 High Power Wireless Repeater @ \$540 each = \$5,400

10 – Solar Power Systems (3 days power with no sun) @ \$2100 each = \$21,000 Installation/Materials/Programming @ \$17,500

Total project cost is \$68,350. As required, the Port of Palm Beach will provide a 25% match of the total project amount, therefore we are asking for \$51,263 to support this project.

This equipment purchase will allow for the monitoring of approximately 6,370 ft. of perimeter fencing adjacent to a high crime area.

This project assists in the implementation of the Port of Palm Beach Security Plan by:

- (a) Assisting in the securing the seaport under the requirements of 33 CFR Part 105.
- (b) The ability for real time notification of perimeter intrusions to Port and law enforcement personnel, allows this to be an enhancement to communication with local, state and federal law enforcement.
- (c) This project increases the efficiency in the screening of cruise passengers, by ensuring that only authorized personnel access the Restricted Areas adjacent to passenger vessels and cargo operations.
- (d) The Port of Palm Beach is prepared to match all funds received through the FSTED Program Seaport Security Grants Fiscal Year 2018/19 program. Port funding will come from the FY 2018 Port Operating Budget.

As a member of the State of Florida Seaport Security Advisory Committee (Committee) representing Port Tampa Bay, and in response to a request for security project proposals issued by FSTED utilizing a State Seaport Security Grant for 2018/2019; I would like to submit the following request:

- A. Description of Security Enhancement: The acquisition of Meridian Rapid Defense Group (Meridian) portable vehicle mitigation barriers, with associated equipment and trailer. The Meridian barrier system is a portable/modular system that utilizes a series of metal barriers and cables to guard against hostile and accidental vehicle intrusions into sensitive/restricted/secure areas containing hazardous materials or mass gatherings of people. This barrier system can be moved from location to location depending on operational security needs, without the use of heavy equipment. Unlike traditional fixed bollards or "jersey barriers", the deployable barriers can be used at the highest at risk locations at that point in time. For example, the barrier can be deployed during cruise season at a passenger terminal, and relocated to a hazmat facility in the off-season.
- **B.** Explanation of Security Enhancement: Meridian vehicle barriers are transported on a trailer with associated equipment by a standard port security truck. The barriers are placed at strategic locations throughout the port complex to guard against accidental or intentional vehicle intrusions. These facilities may include cruise terminals to protect passengers arriving or departing the facility, cruise terminals to protect shore side operations on the berth, or at petroleum facilities to protect critical hazardous materials transfer locations. This enhances the screening process by providing additional protections to those areas where that activity occurs.
